## PRACTISING CERTIFICATE (AMENDMENT) REGULATIONS 2020

The Council of the Law Society of Northern Ireland in pursuance of the powers conferred upon them by Articles 74(1) and 75(1) of the Solicitors (Northern Ireland) Order 1976 (as amended) and all other powers enabling them in that behalf and with the concurrence of the Lord Chief Justice of Northern Ireland hereby make the following Regulations under Article 10 of the said Order:-

- These Regulations shall be called the Practising Certificate (Amendment) Regulations 2020 and shall come into operation on the 23<sup>rd</sup> day of November 2020.
- 2. (1) The Interpretation Act (Northern Ireland) 1954 shall apply to the interpretation of these Regulations as it applies to a statutory instrument.
  - (2) In these Regulations 'the Principal Regulations' shall mean the Practising Certificate Regulations 1982 and any reference to a Regulation by number is to the Regulation so numbered therein.
- 3. The Principal Regulations are amended as follows.
- 4. For Regulation 3 of the Principal Regulations there shall be substituted the following Regulation:-
  - 3. Every applicant shall deliver to the Society no later than 5<sup>th</sup> January in each year an application in Form PCR1A correctly completed by the applicant.
- 5. For Regulation 6 of the Principal Regulations there shall be substituted the following Regulation:-

- 6. Every practising certificate shall be delivered to the applicant.
- 6. In Regulation 7(1) of the Principal Regulations the text 'by delivering at the Society's offices either by post or in person or by his agent' shall be substituted with the text 'by providing to the Society'.
- 7. In the Schedule to the Principal Regulations there shall be inserted the Form PCR1A appended hereto.
